

DIRECTIONS

MMS Headquarters at Waltham Woods
860 Winter Street, Waltham, MA

FROM BOSTON: West on Mass. Pike/I-90 to Exit 15. Keep right beyond tollbooth. Take Rte. 128/I-95 North to Exit 27B (Wyman Street/Winter Street). Turn right at lights (Wyman Street) and continue right onto Winter Street. Stay in right lane on Winter Street to cross back over Rte. 128/I-95. (See "All" below.)

FROM THE NORTH: South on Rte. 128/I-95 to Exit 27B (Winter Street). (See "All" below.)

FROM THE SOUTH: North on Rte. 128/I-95 to Exit 27B (Wyman Street/Winter Street). Turn right at lights (Wyman Street) and continue right onto Winter Street. Stay in right lane on Winter Street to cross back over Rte. 128/I-95. (See "All" below.)

FROM THE WEST: East on Mass. Pike/I-90 to Exit 14. Keep left beyond tollbooth. Take Rte. 128/I-95 North to Exit 27B (Wyman Street/Winter Street). Turn right at lights (Wyman Street) and continue right onto Winter Street. Stay in right lane on Winter Street to cross back over Rte. 128/I-95. (See "All" below.)

ALL: Stay in far right lane through two sets of lights. Travel around the reservoir for approximately 0.5 mile. Turn left at granite sign for HealthPoint and Waltham Woods Corporate Center. Follow green signs to Waltham Woods Corporate Center to next granite sign for Waltham Woods (860–890 Winter Street). After sign, turn left into the Massachusetts Medical Society.

FACULTY

HARVEY V. FINEBERG, MD, PHD, is president of the Institute of Medicine. He served as provost of Harvard University from 1997 to 2001, following thirteen years as dean of the Harvard School of Public Health. He has devoted most of his academic career to the fields of health policy and medical decision making. Dr. Fineberg helped found and served as president of the Society for Medical Decision Making, and also served as advisor and consultant to the U.S. Centers for Disease Control and the World Health Organization. At the Institute of Medicine, he has chaired and served on a number of panels dealing with health policy issues, ranging from AIDS to vaccine safety. He is the author, co-author, and co-editor of numerous books and articles on such diverse topics as AIDS prevention, tuberculosis control, assessment of new medical technology, clinical and public health decision making, and understanding risk in society.

CAROLYN M. CLANCY, MD, is the director of the Agency for Healthcare Research and Quality (AHRQ). Prior to her appointment as director, Dr. Clancy served as AHRQ's acting director, and as director of AHRQ's Center for Outcomes and Effectiveness Research.

Dr. Clancy is a general internist and health services researcher, and a graduate of Boston College and University of Massachusetts Medical School. She holds the academic appointment of clinical associate

professor in the Department of Medicine at George Washington University School of Medicine and serves as senior associate editor for Health Services Research. Dr. Clancy is a member of multiple editorial boards ([American Journal of Public Health](#), [Annals of Family Medicine](#), [Journal of General Internal Medicine](#), and [Medical Care Research and Review](#)). She has published widely in peer-reviewed journals and has edited or contributed to six books.

JAMES P. BAGIAN, MD, PE, was chosen as the first director of the Veterans Affairs' (VA) National Center for Patient Safety (NCPS) in 1998. As NCPS director, he is responsible for overseeing the entire operation of the Center. NCPS uses a systems approach to error measurement, and development and implementation of techniques designed to reduce avoidable injuries and deaths throughout VA's 173 medical centers and over 771 outpatient facilities.

Dr. Bagian served as a NASA astronaut and is veteran of two space flights — STS-29 in 1989 and STS-40 in 1991 — and has logged over 337 hours in space. He took part in both the planning and provision of emergency medical and rescue support for the first six space shuttle flights.

MODERATORS

JEFFREY M. DRAZEN, MD, editor-in-chief of the [New England Journal of Medicine](#), is currently the Distinguished Parker B. Francis Professor of Medicine at Harvard Medical School. He has served as chief of Pulmonary at the Beth Israel Deaconess Hospital, the combined Divisions of the Beth Israel and Brigham and Women's Hospitals, and finally, as the chief of Pulmonary at Brigham and Women's Hospital. Through his research program, he defined the role of novel endogenous chemical agents in asthma. This led to four new licensed pharmaceuticals for asthma, with over 5 million people on treatment worldwide.

GREGORY D. CURFMAN, MD, has been the executive editor of the [New England Journal of Medicine](#) since 2000. At the [Journal](#), Dr. Curfman is responsible for the editorial development of the front section, he provides editorial oversight for articles dealing with cardiovascular medicine, and he oversees the activities of the editorial office.
